She holds a Professional Dancer Diploma from the Royal Ballet School in London, an MA in Dance Studies from the University of Surrey, and an M.Ed degree from the University of Sheffield.

Anna has held several influential roles in the arts, including Chairperson of the Hong Kong Dance Alliance, Vice-President (East Asia) of the World Dance Alliance Asia

Pacific, Head of Dance at the West Kowloon Cultural District Authority, Advisor of the Hong Kong Arts Development Council and currently, Professor and Dean of School of Dance at The Hong Kong Academy for Performing Arts.

Throughout her career, Anna has launched several important programs and initiatives, including the Gifted Young Dancer Programme, award winning projects "Performing Arts Marathon @Shum Shui Po" and "Jockey Club Dance Well Project" at the Hong Kong Academy for Performing Arts, and a series of programs at the West Kowloon Cultural District Authority that offer Hong Kong artists a platform to explore innovative forms of creating and performing with international artists. She has also collaborated with project development teams, architects, and theatre designers on the design of several prominent performing arts spaces in Hong Kong.

Anna has been widely recognized for her outstanding contributions to dance education, promotion of Hong Kong dance, and innovations in ways to create, present, and sustain dance. She has been invited as a keynote speaker, presenter, and guest lecturer in many international symposiums, festivals, and conferences worldwide.



As the Head of HR for English Schools Foundation,

Charles says "My Ceiling Is the Next Generation's Floor."

Charles explains: to prepare students for the future we need to emulate a future-proofed workforce today. He uses an Al Assistant name Evie, two Al coaching tools (Replika & Rocky) and other Al tools for tricky HR situations. Charles says digital is not about speeding things up, but slowing things down to give leaders time to reflect.

Originally from Toronto, Canada, Charles holds degrees in Administrative Studies, Asia Pacific Management and a Kellogg–HKUST Executive MBA. Starting his career as a young entrepreneur, he landed on Canadian Business Magazine's cover at 22. Charles joined corporate when he moved to Hong Kong in 1996 as Director Sales & Marketing, Achieve Forum. From 1998 to joining ESF in 2011, Charles was APAC HR director for Rockwell Automation, Citrix Systems & Juniper Networks.

A believer in servant leadership, Charles has delivered two TedX Talks: "Leading Through the Green Light," and "Love as a Leadership Skill". He has spoken in person and virtually to many organizations and conferences including the Economist, HR Magazine, HRM Asia, AECON, AT&T and most recently the annual HKIHRM Conference. In 2019 Charles was rated a Top 100 Global HR Hero by the Global Human Resources Director Congress and in 2020 an "APAC HR Superstar" by HRO Today. Charles is also a digital nomad and top-rated Level 2 seller on Fivver, completing over 300 gigs in four years.

Charles is a Resting Deacon of Union Church and a Board Member for International Care Ministries – an organization dedicated to helping the ultra-poor in the Philippines. Charles is very involved in a variety of mentoring initiatives in Hong Kong. Charles is married to Tess and has four children including triplets. He says, "I have headcount issues everywhere."



Jen is currently the Group Head of Customer Intelligence and Partnerships at HSBC Wealth & Personal Bank. She is an avid design thinking and innovator helping companies be more customer centric and thinking outside the box. Outside of work she actively involved in women communities and was the co-founder and founder of TEDxTinHauWomen and TEDxShanghaiWomen. She is on the board of the American Chamber and serves on the Women of Influence steering committee. She has also recently joined the HK Chapter of Asian University of Women (AUW) helping sending women to university, get

internships and job placements post graduation.
