He has also been actively engaging in RMB internationalisation and cross-border business activities since 2009. Mr Chiu joined HKEX in 2018. Prior to his current role, Mr. Chiu was Senior Vice President of Fixed Income and Currency (FIC) Development responsible for FIC derivative and bond listing businesses at HKEX. He holds an MSc in Mathematics for Finance and Actuarial Science from the Université Paris-Dauphine and a BBA in Finance from the Hong Kong University of Science and Technology.
